Minutes for the meeting held at Snohomish County Fire District #26 Station 53 January 10, 2012

Secretary Report – Reported on calls and account status.

Budget Report - Reported Fire 26 budget was at 7% and the Sky Valley Fire and Rescue was at 8%.

Review of the annual call statistics report. There was a small increase in call volume.

The attorney completed the public disclosure information requests for Ms. Block. After discussion we will give any more requests on this will go thru Commissioner Wood.

Chief Andrews wrote our representative on the issue of public disclosure and its impacts on small government agencies. All except our Senator replied. The board reviewed the year ending financial revenue report and the yearend

expense report.

The board reviewed a look at the revenue from taxes from the past several years and the estimated loss that we will see in the coming years. Discussion on running an M&O levy that would help the district obtain some financial relief to offset the lost revenue. A motion was made by Commissioner Tubbs and seconded by Commissioner McClellan to run an M&O levy in August 2012. Motion unanimously approved.

A retreat is being planned for April for the leadership of the department and bring in an outside speaker one day and the second day work on goals for the department.

Commissioner Moore nominated Linda Larsen as secretary of the board. Commissioner Tubbs seconded the motion. A motion was made by Commissioner McClellan and seconded by Commissioner Williams to close nominations. Motion for Linda Larsen as secretary of the board unanimously approved.

Old Business:

Commissioner McClellan commented on the 4th quarter safety meeting that was held December 2011. There were only a few minor accidents. Commissioner McClellan commented on the good job Marney Larsen is doing in running the safety program.
